Subject: This is the notice of “The National Taiwan University 2024 Second Semester Election” including types of elections, period and requirements for the second round of candidate registration.

According to Article 1 and Paragraph 3 of Article 22 of “National Taiwan University Student Association Election and Recall Act” and Article Paragraph 3 of Article 38 of “Public officials Election And Recall Act”.

1. Types of elections, period and requirements for the second round of candidate registration:
 - (1) Student Members of Gender Equity Education Committee:
 - a. Registration period: April 14th to April 16th, 2025.
 - b. Requirements: The number of registered candidates did not meet the required of seats before the deadline of the first round of candidate registration.
 - (2) President of Student Association of Department of Social Work:
 - a. Registration period: April 14th to April 16th, 2025.
 - b. Requirements: No candidates registered before the deadline of the first round of candidate registration.
 - (3) President and Vice President of Student Association of the Department of Economics:
 - a. Registration period: April 14th to April 16th, 2025.
 - b. Requirements: No candidates registered before the deadline of the first round of candidate registration.
 - (4) President and Vice President of Student Association of Department of Electrical Engineering:

- a. Registration period: April 14th to April 16th, 2025.
 - b. Requirements: No candidates registered before the deadline of the first round of candidate registration.
2. Registration method, important notes, and registration form for the second round of candidate registration:
Same as those for the first round of candidate registration.

第一條 【法源依據】

本辦法依國立臺灣大學學生會選舉罷免法(以下簡稱本法)第十八條第二項訂定。

第二條 【登記方式】

本會選舉除另有規定外，選舉罷免執行委員會(以下簡稱選委會)應於第一份選舉公告上載明受理登記之方式。

第三條 【候選人照片之格式】

候選人登記表之照片，應符合下列規定：

- 一、 近期內所拍攝。
- 二、 為候選人個人之正面證件照或生活照，且不得有其他人之影像。
- 三、 無墨跡、摺痕、反光，或其他足以影響辨識之相片缺陷。繳交實體照片者，應以高解析度沖(列)印於至少兩寸之光面相紙上；繳交數位照片者，應提供長、寬至少六百像素之影像。

第四條 【在學證明之格式】

以數位格式繳交在學證明者，應提供自本校網站線上申請下載之原始檔案，或紙本在學證明之掃描件。

在學證明應於當次選舉候選人登記期間內申請。

第五條 【保證金之收取】

選舉訂有規費或保證金者，候選人應依公告之期限與方式，向選委會或指定之代收機構繳納之。

第六條 【不合程式之效力】

登記表件不合規定者，選委會應命其在合理期間內補件或修正至多一次；逾期未補正者，應拒絕受理其登記。

第七條 【施行日期】

本辦法自公告日施行。
